9. Mr. Mitchell's perspectives on managing risks and capitalising on opportunities within FM contracts will enhance our comprehension of international best practices. It is also an honour to have Mr. Arivagara Pavithran Subramaniam, the CEO of Maxwell CFM International and who is also a Malaysia member of ISO/TC 267 joining us onboard as a co-facilitator for the session. Their collective knowledge will enable participants to navigate contractual risks adeptly and discover new avenues in this dynamic industry.

10. This seminar further highlights the importance of cooperation among various sectors. Facility management is inherently collaborative as it necessitates robust alliances between the public and private sectors to realise common objectives. 11. Ultimately, it is essential that we adopt international standards and cutting-edge technologies such as Building Information Modelling (BIM). These tools and practices play a crucial role in fostering sustainability and enhancing Malaysia's stature as a prominent player

in the field of facility management on the global stage.

As the Construction Industry Development Board (CIDB), we are committed to promoting the adoption of best practices in Facility Management, with the aim of ensuring that our nation's-built environment is managed in a sustainable and efficient manner. We are committed to establishing exemplary standards nationwide, striving for optimal operational efficiency while reducing environmental impact. Sustainability has evolved from being a mere aspiration to becoming an essential requirement for the future of our industry.

13. As of September 2024, the Construction Industry Development Board (CIDB) has registered 574 contractors under F01 specialization for Building Facility Management and 92 contractors under F02 specialization for Healthcare Facility Management. These contractors

satisfy the rigorous standards of CIDB, ensuring that they are capable of overseeing facilities in a safe and efficient manner.

14. Yet, as we forge ahead, we must not overlook the human element of facility management. The success of our industry hinges on the development of a skilled and adaptable workforce.

15. As we embrace innovation, we must also invest in training and education to equip our workforce with the skills they need to thrive. The International Facilities Management Association (IFMA) reports that 73% of facility managers believe ongoing training is essential for adapting to technological advancements. By providing access to training programs and fostering a culture of continuous learning, we empower our teams to excel, innovate, and lead.

16. In addition, the Facility Management Manager (FMM) and Facility Management Executive (FME) Accreditation Programmes have been prioritized by CIDB for the development of human capital in FM. To date, 311 professionals have been certified as FMMs, and 70 professionals have received their FME certification. These programs

are intended to improve the quality of facility management services and ensure that professionals meet industry standards by upskilling them.

17. CIDB anticipates a substantial increase in the number of professionals in this sector over the next five years, as facility management garners the attention of key stakeholders. These professionals will be instrumental in elevating facility management in Malaysia to new heights, thereby guaranteeing global competitiveness and excellence, as the industry expands.

18. CIDB's dedication to the advancement of the facility management industry is exemplified by these initiatives, which guarantee that our professionals and contractors are prepared to meet the demands of agile facilities and remain highly viable.
